A message from the Chair

Dear CAIPE Member

It has been a very active June for CAIPE.

On 12 June CAIPE Chair was the keynote speaker at the Lambeth Early Action Partnership Workshop. They were the Team winners of the 2018 John Horder Award and the workshop provided opportunity to explore the challenges and benefits of collaborative working through interprofessional education and the achievements reached by LEAP. It was an excellent workshop and opportunity to meet and discuss with stakeholders from the voluntary sector support provided to the Lambeth Early Action Partnership initiative. The CAIPE Annual General Meeting was held on **Thursday 13th June 2019** and the Chair welcomed members to the Review of CAIPE Activities over the last year and approval of the Annual Accounts. As you will read in the Report CAIPE has been very active over the past year with Board members leading on various Working Groups. I would like to thank all Board members for their commitment and contributions to the continuing development and promotion of CAIPE. Sadly, we had to say goodbye to Kate Parkin and Jenny Ford who have resigned as Board members and thank them for many years of constructive and innovative contribution to the work of CAIPE.

We would like to encourage more CAIPE members to attend the Annual General Meeting as it is a celebration of CAIPE Achievements and activities. Post AGM we will continue to plan an event which will be open to members and non-members.

The John Horder Award 2019 followed this year's AGM. Hugh Barr, CAIPE President welcomed attendees to the event. Hugh provided an insight and personal tribute to the man behind the John Horder Award, some of which is included in the CAIPE AGM Report and Accounts. Dr Sanjiv Ahluwalia, Postgraduate Medical Dean at Health Education England North Central and East London and General Medical Practitioner provided the Keynote presentation: **"Collaboration in General Practice- a personal perspective".** (Presentation pdf). Sanjiv has had a long association with CAIPE for its knowledge, skills and expertise. He provided a personal perspective sharing the impact John Horder had had on his collaborative practice stating that the journey of interprofessionalism in General Practice

is a team sport.

Rachael Kilner and Octavia Wiseman presented on behalf of the 2018 Team Award: The view from the front line: Family-centred care `from conception to reception' in Lambeth. Dr Rachael Kilner, LEAP General Practitioner and Locum, The Tulse Hill Surgery, Lambeth, Co-Presenters; Ms Octavia Wiseman, LEAP Midwife, Kings College Hospital, Ms Claire Spencer, LEAP Midwife, Guys and St Thomas's NHS Foundation Trust and Breastfeeding Coordinator and Ms Carla Stanke, LEAP Public Health Specialist.

The LEAP (Lambeth Early Action Partnership) health team initially spent time shadowing each of their colleagues in each of the three professional areas –midwifery, health visiting and general practice. They then met with a range of professionals and families to understand what the system is like now, areas that work well and areas that could work better. The professionals involved in these meetings were cross boundaries –i.e. secondary care and primary care together, across professional job boundaries i.e. midwives and GPs, and practice nurses, and also across health and council service boundaries –children centre managers and commissioners from the council, GPs, public health specialists. This crossboundary working is a key recommendation from the Better Births Maternity Review. (presentation pdf).

Caoimhe Cooke and Johanne Barry presented on behalf of the 2019 Team Award: 'Pharmacy and Medical Students' Views on an Innovative Interprofessional Simulated Learning Activity' Caoimhe Cooke¹, Gerry Gormley², Sharon Haughey², Johanne Barry² ¹Centre for Medical Education, Queen's University Belfast, Belfast, Northern Ireland; ²School of Pharmacy, Queen's University Belfast, Belfast, Northern Ireland The presentation outlined the discussion of an innovative medical and pharmacy interprofessional simulation-based learning activity, developed by a team of researchers in Queen's University, Belfast. The project was designed to address the need for medical and pharmacy professionals to work openly and effectively as collaborators, with the aim of addressing their professional hierarchies and pitfalls in order to minimise prescribing and dispensing errors. Unfortunately, the 2018 Student Award winner *Mr Danial Naqvi, Medical Student, Imperial College* London was unable to present in person. However, Sundari Joseph, CAIPE Vice Chair provided an excellent stand in following a script from Danial and slides and presented **'Improving integration between primary healthcare and social care for the frail and elderly population'.** Danial is a 5th year medical student who intercalated last year at the Imperial College Business School to undertake a BSc degree in Management. Through this degree he developed an interest in not only clinical medicine but also interprofessional working and the managerial side to healthcare.

The 2019 Student Award winner was Erin Gilmour, 5th Year Pharmacy student from Robert Gordon University and Erin will be presenting **`An interprofessional approach to supporting substance misuse patients in primary care'** in our next E-Newsletter.

Proposed Federation of Healthcare Education

Following being a panel member at an event in September 2017. CAIPE have now been contacted again by John Jenkins, Derek Gallen Julie Brown and Alison Bullock who have reviewed their thinking about the initial proposal of a Federation, with the objective to strengthen the communication links between healthcare education organisations in the UK and Ireland. They have undertaken a study of shared values and activities across the healthcare professions and are developing a paper for submission, as well as for presentation at relevant conferences. They presented the work at the Dublin meeting of INHWE (the International Network for Health Workforce Education) in January, where it generated a lot of interest. They are now beginning to give renewed thought to how best to reactivate their desire to discuss with other key interests (including CAIPE) in order to find the most effective ways to further their original objective, whether or not this would mean the development of an actual Federation organisation.

CAIPE Website

Our Web Manager has terminated her Contract of Service with CAIPE to provide web management services with effect from 9 April 2019. Emma Beal, CAIPE Administrator and Richard Pitt, Chair at present will continue to manage the web site and following training in June with Craven Digital may be in a position to engage others. The training day attended will lead to an upgrading of the website system to provide a more efficient and easily navigable website. This work will be undertaken over the coming months and will be ready for September.

ZOOM

We have now taken out a monthly subscription to Zoom to reduce carbon footprints; reduce travel costs and improve video conferences for meetings. Monthly subscription provides unlimited meeting time and up to 49 participants on screen (see https://zoom.us/meetings). We are encouraging CAIPE Working Group Leads to utilise Zoom for their meetings and the Executive Group and Board will be using it for some meetings. It also enables CAIPE to open events to members to attend and participate virtually.

CAIPE Board Members Away Day

Zoom was successfully trialled at the CAIPE Board Members Away Day hosted by the University of Central Lancashire, Preston with 5 members joining the discussion virtually. The objective of the day was related to exploring potential themes for future publications in the CAIPE/Routledge Collaborative Practice Publication series and areas for CAIPE interprofessional Research.

CAIPE Executive Group

The Executive Group met at UCLAN the day before the Away Day and predominately explored budget management and development of relevant policies. It was also noted that there had been increased interest in the CAIPE Workshop series.

EIPEN Membership

We have received the following communication from EIPEN Chair, Andre Vyt:

"In the previous years we exceptionally allowed provisionally that board members of CAIPE can benefit from reduced registration fees for EIPEN conferences, while according to the regulations this is only for staff members of an institutional member. We are now updating our membership statuses. For associations and networks, we are now proposing cooperation agreements instead of memberships. Active membership of EIPEN is for institutions, and supportive membership for individuals.

As CAIPE is not a European association, and as the UK has a very specific (some would say "awkward") relationship with Europe, such a cooperation agreement is not obvious but if you would like to envisage this, we can discuss it of course. If you would like to continue CAIPE's membership, please let us know and then we can discuss it in our Executive Office". In-light of this communication the Executive recommend to the Board that CAIPE no longer pursues Institutional Membership of EIPEN but open a dialogue with them as a Regional IPE Network the proposal of a cooperation agreement.

We will be taking a break from the E-Newsletter over the summer with a new look being launched the first Monday of October.

Guest Editorial

As a Speech and Language Therapy Student in 2002 I used to value the Interprofessional Lectures and workshops, and thrived on learning to work 'with from and about' other professionals to improve the quality of care. I never expected to be able to step into the 'true' shoes of a service userpatient, prior to degree completion. However, 8 weeks prior to degree completion, I had a car crash resulting in serious injuries and becoming a health, medical and social service user.

Throughout my journey of recovery, collaboration between interprofessionals, wasn't always there, so they did and didn't always 'work with, from and about' each other (Caipe 2002) However when there was collaboration, then my recovery towards 'life' independence, was enhanced further. On reflection I value and understand the positives and negatives of interprofessional collaboration, and have been inspired to share that. The growth of 'nothing for me without me' with a holistic approach, should start with educating tomorrows health and medical, and social professionals. It is a message that I believe is embedded by involvement of service users in, and work of CAIPE, very much becoming established within higher education institutes (HEI's) training in Inter Professional Education (IPE). It is 110% invaluable to have the service user involvement in IPE, because at the center of an interprofessional team working is the patient, as without them, there would be no need for different professional's working together, and collaboration of care.

My involvement in working with Inter-Professional Education (IPE) began 5 years post accident, working with the University of Leicester and De Montfort University. This work commenced with working with IPE modules, telling my journey of recovery at 'Listening Workshops' where Multi-Disciplinary Teams (MDT) of medical, health and social students, actively listen to the journey of service users: ex or current patients, and ex or current carers, then collaborate to give presentations reflecting on what they have learnt, and will potentially take with them into placements and practise.

My knowledge of and working with CAIPE commenced in 2013 with partaking in a CAIPE student conference on IPE and service user involvement, with a CAIPE board member from De Montfort University. My personal reflections from that conference were: "i got a really good vibe that there is a want, and definite need for development of IPE. As an ex student, professional+client with a passion for IPE to hear a development of+share a true understanding of it, from and with students+professionals, was really positive, that there is hope for it to develop further in the nr future. I would love to play a part in further raising awareness of it."

Throughout my work with IPE both with CAIPE and Leicester Universities, I have been involved in meetings, lectures, workshops and conferences, in person, and online using social media.

Looking at core themes in health and medical fields such as compassionate care, patient safety, and equality and diversity, from a service user perspective. Taking forward positives developing medical, health, social IPE for tomorrows professionals to learn together to work together, to improve care.

Service users, support and encouragement from most academics, and medical professional's, has been positive, reflects how our input is valued, and we can be an integrated member of the academic team. Meetings, discussions, and presentations between service users and academics enables this further.

Though sometimes it has been felt the need for service users in education has been frowned upon, by some academics and health medical professionals who think they are delivering IPE, but may not actually be. Then hearing and seeing the involvement of the service users stories on IPE work, feedback we have received , shows how their views have changed. So the theory of 'you can't teach an old dog new tricks', is pushed aside when their reflections show, they can see the need for IPE and Service Users involvement, and the integration of the patient voice.

Throughout my work with the two Leicester HEI's, has seen my participation in, further development of and creation of service user groups. Developing and refreshing strategies for service user involvement at both, shows the further involvement of service users being utalised in IPE. The GMC's requirements for patient and public involvement in undergraduate medical education are outlined in Tomorrow's Doctors (2009) My work with IPE and CAIPE has given opportunity to learn about and fulfil this.

In 2016 CAIPE created a new membership category of service users, I was co-opted as a service user representative on the board of CAIPE, which has furthered my involvement in IPE with CAIPE.

The growth of the importance of service user roles within education, has enhanced service users and my, involvement as part of the academic teams. Leicester's co re-structuring the listening workshops, allowed us as service users to feel and become more integrated in the workshops, and through mentoring others. Through mentoring it promotes involvement of service users, allow shadowing, and support. Co-tutoring allows us to become partners in education assisting/leading the workshops. Involvement with CAIPE has allowed me to see how different HEI's are utalising, or not, IPE and service users in education and, has allowed me to support in promoting IPE spreading the message of how to 'learn together to work together'. Which is happening World Wide.

Health Education England (HEE) exists for one reason only: to support the delivery of excellent healthcare and health improvement to the patients and public of England by ensuyring that the workforce of today and tomorrow has the right numbers, skills, values and behaviours, at the right time and in the right place.'

Latterly with CAIPE has seen my involvement in development of IPE workshops for trust and HEI's funded by HEE South. Workshops utalising service user voices, structures like the listening workshops in Leicester. Involvement im meetings and presentations, and trial workshops, through face to face and online meetings.

The GMC's requirements for patient and public involvement in undergraduate medical education are outlined in Tomorrow's Doctors (2009) My work with IPE and CAIPE has given opportunity to learn about and fulfil this.

I have seen IPE grow, with the growth of the internet and social media. Through online discussions about workshop development between Involvement with CAIPE student Twitter Chats, and Leicester Universities use of PKB (patients know best) online consultation programme. This promotes the use of the internet, and social media for communication working with IPE. With CAIPE I have attended conferences where Patient Voices' digital stories have been presented. The stories and narratives are very powerful, and they are individual, and developed by healthcare professionals, students or patients. Which again shows strength of internet and learning IPE, and the work of CAIPE.

Violence against women is a major public health problem rooted in gender inequality and is a gross violation of women's human rights, affecting the lives and health of millions of women and girls. This framework outlines steps for a public health and human rights approach to scaling up programmes to prevent violence against women. It builds on the evidence compiled in the 2015 UN prevention of violence against women framework and from additional systematic reviews.

This report considers the overall impacts on health of the Sure Start programme as a whole between its inception in 1999 and its peak in the late 2000s. The report focuses on health outcomes as while Sure Start's services were multifaceted and varied between centres and over time, one of its main objectives was to improve children's health.

English council funding: what's happened and what's next?

This report finds that overall spending on local services by English councils fell by 21 per cent between 2009–10 and 2017–18. Findings include that services such as planning and development, housing, culture and leisure, and highways and transport saw the biggest cuts. Spending on social care services fell by 5 per cent although the numbers of people receiving care fell by more. The report also looks to the future, and summarises the funding options and issues for councils as we approach the 2020s.
