- Regulation of Health and Social Care Professionals Joint Law Commissions Consultation. In the UK today there are around 1.4 million health professionals working in 31 different professions governed by nine separate regulatory bodies. The Law Commissions for England and Wales, Scotland and Northern Ireland are seeking views on the regulation of health care professionals in the UK and social workers in England. The aim is to make the current complex arrangements for professional regulation clearer, simpler, more modern and more consistent. The consultation opened on March 1st and the Commissions seek responses by 31 May 2012. - An e Petition for District Nursing. District nurses have long provided expert nursing care for people at home, working collaboratively with and most often acting as the key coordinator for, other professions involved in that care. There is increasing concern that the district nursing services are in decline whilst policies aim to move 80% of care into the community. There is now an ePetition on http://epetitions.direct.gov.uk/petitions/30029 This petition requires the Department of Health to ensure that the appropriate infrastructure, including the education and preparation of District Nurses is put in place. When an ePetition reaches at least 100,000 signatures, it will be eligible for debate in the House of Commons.
