IFIC Canada launches first North American Virtual Community for Integrated Care

Throughout North America, there are many challenges and disruptions occurring across the health system. IFIC Canada, the North American Centre for Integrated Care has been established to create a platform to improve the capacity of individuals and organizations in advancing integrated care. IFIC Canada will focus on the principle of people-centred, co-designed care and to achieve our goal of progressing integrated care throughout North America, we are creating a virtual community to bring together all those involved in Integrated Care.

The first meeting of the **IFIC Canada Virtual Community** will take place on Tuesday, 14 May at 12pm EST. These online meetings will bring together people who want to make positive change within health and social care in Canada and the wider North America region.

The virtual community is convened by the International Foundation for Integrated Care (IFIC), The Change Foundation and the Institute of Health, Policy Management and Evaluation (IHPME) from the University of Toronto. This will be the first session of a monthly series hosted by IFIC Canada bringing people together from across North America who are interested in advancing integrated care. Together, we will learn from innovative integrated care practices around the world – and from each others' experiences - so that we can facilitate integrated care and create positive change in North America. We will also look to the community to guide the focus for future webinars of the virtual network.

The inaugural convening of the IFIC Canada virtual community will take a tour of integrated care around the world through the eyes of Dr Nick Goodwin, CEO of IFIC. Also joining us for the first webinar will be Dr. Walter Wodchis and Dr. Ross Baker from IHPME, with the session being facilitated by The Change Foundation's Jodeme Goldhar.

Carole Ann Alloway, Caregiver talks about the importance of co-design

In her blog Carol Ann Alloway talks about her experience of presenting at the 18th International Conference on Integrated Care which took place in Utrecht in 2018 and looks forward to the coming of NACIC 2020 to Toronto and her involvement in the planning the committee.

In February of 2018 I got an email from Jodeme Goldhar, Executive Lead – Strategy and Innovation at The Change Foundation asking if I would be interested in speaking with her at a keynote address of ICIC18 in Utrecht, the Netherlands. So many emotions and questions went through my mind as I read and then re-read her email. Excitement, honour, fear and then excitement again! I jumped in with both feet because I trust Jodeme and The Change Foundation. We have the same values and we want to make caregivers' lives better.

I am a caregiver for my husband who was only supposed to have one operation but had 10 over 7 years and also developed heart and gastro issues. Exhausted, isolated, frustrated and alone were my emotions then, although I hid them behind a cheery smile and a 'can do' attitude. I was angry when I was diagnosed with depression because I felt I was a strong person. I thought, 'how/why did this happen?'. So, I wrote a Caregiver Wishlist and shared it with Cathy Fooks, President and CEO of The Change Foundation. They invited other caregivers to contribute to the Wishlist and developed a video which has sparked more Caregiver Wishlists and videos.

But back to Utrecht. When I met with Jodeme, I had many questions – what message did we want to send? How would the talk be structured? What part would I play? Jodeme's answer was – 'let's co-design the talk together'. Imagine that! [Read more ...]

Carole Ann Alloway is a retired Human Resources Manager, mother of four and grandmother of seven. Carole Ann became a full-time caregiver for her husband, Bill, who had ten difficult op-erations within a 7-year period. In addition, Bill's gastro issues worsened, and he developed congestive heart failure. She has witnessed first-hand the gaps in the health care and home care systems. Together with Sara Shearkhani, another caregiver, they have co-founded Family Caregivers Voice.

Canada make a growing contribution to the global movement for change



In his blog, Walter Wodchis reflects on Canada's involvement in the 19th International Conference on Integrated Care and the opportunity to learn from other countries, but also the platform presented for sharing Canada's growing experience in designing and delivering integrated care.

The ICIC19 conference in Donostia-San Sebastian was a wonderful opportunity for Canadians to learn who in Canada is working to better understand, improve and advance integrated care. This year's conference was attended by the largest number of Canadian delegates to date with more than 40 participants, many of whom gathered for an early breakfast on the final day of the conference hosted by the Health Standards Organization. Everyone was highly engaged and involved throughout the conference: Canadian contributions included a keynote talk by Dr. Henry Mintzberg, 22 oral presentations, 12 poster presentations, 11 session chairs and 6 workshops involving 19 presenters (clearly some people had multiple contributions). Dr. Jacobi Elliott was awarded Best Poster of the Conference (having already won the Best Poster award in 2016 in Barcelona and Runner*Up Poster in 2014 in Sydney). More than that though, the Early Researchers in Integrated Care is an international group led by Mudi Kadu, a PhD student at the University of Toronto, and three other Special Interest Groups are facilitated or co-facilitated by Canadians including Digital Health Enabling Integrated Care, Volunteers and Voluntary Sector, and Advanced Education in Integrated Care. Canada is clearly on the map of integrated care.* [Read more ...]



Social injustice is killing on a large scale




With a record number of abstracts received for ICIC19, the conference featured over 350 presentations across a range of plenary sessions and breakouts, 125 workshop and Special Interest Group Meetings, 450 posters on display, and once again the Innovation Zone on Wednesday afternoon featured 12 experiential workshops, and the opportunity to visit a range of local health and social care service sites.

Conference highlights included a presentation on Day 2 from Michael Marmot on the social determinants of health. Micheal warned of the crisis in life expectancy and that after a dramatic increase, many western countries have flat lined or are in decline. To avert this crisis, we need to look to the social determinants of health and understand why people are turning to drug use or other unhealthy habits, are committing suicide, and are generally living less well. He pointed to Costa Rica and Cuba who have longer life expediencies, with considerably less money. The social conditions for the poorest are now better in Costa Rica and Cuba than in the US. Later in that same session Maria Angeles Duran asked what do we mean by care giving, and if it only involved paid care? We have not clearly defined the concept. How can we socially recognise caregivers (women)? When they get old, who will care for them, and why are we not paying them for their efforts? She noted that men die rich because they sell their time for money. But women work for free. <u>Watch Maria's thought</u> <u>provoking presentation here</u> (en español)

In Plenary 3 Henry Mintzberg told Viktoria Stein that we need to move from evidence to experience. Measuring can destroy care, and you simply cannot measure everything. But you don't measure learning. He said we must be careful not to let measurements control us. He said that there was too much categorization, commodification and calculation and considered the effect this has on the quality of services? The three Cs need to be recognized for how they hinder as well as help the practices of health care. He reminded us that management and leadership is intertwined, a leader must manage, and a manager must lead. Mintzberg declared that 'Healthcare is not a business!'. More Plenary Highlights



IFIC, two decades bringing about transformational change for people and their health and wellbeing



Dr Toni Dedeu joined IFIC in October 2018 as Director of Programmes, but has had a long relationship with the Foundation spanning two decades, and has been a key player in the integrated care movement internationally. Here, as he takes over the baton at IFIC, Toni reflects on the Foundation's journey and the progress made in the 'Movement for Change' as we move into our third decade. "The 19th International Conference on Integrated Care (ICIC) bears the imprint of two decades of transformational change in health and social care provision. The evolution of care service delivery has gravitated from supply to demand. This is reflected in the evolution of the key topics discussed in ICIC conferences and is echoed in the cultural changes that have taken place behind the scenes. This latest conference reflects this sea change: its driving message was that of engaging and empowering people and communities to become equal partners in care. In the conference people were able to discuss and share knowledge, not merely from the theoretical perspective but also providing evidence of implementation and evaluation of person and population centred care. Not many conferences bring together topics such as the role of carers and pharmacy offices in the community, inviting such a wide range of professionals from a large number of sectors to the debate.

The seven thematic areas enabled the delegates to design their own journeys. Participants started arriving early in the morning and when sessions began the rooms were brim-full of lively participants in search of new knowledge on topics such as: codesign and coproduction in care; social design; innovative strategies to activate the community; managing beliefs, expectations and priorities; reassessing health promotion, disease prevention and community health, and finally, models of care for people. They were also eager to learn more on the latest initiatives to improve care of vulnerable populations and populations at risk and co-participating in defining measures and outcomes that matter to people or learning about the impact of technology-enabled care. The bulk of the information was shared in the plenary sessions, interactive workshops, oral presentations, the innovation zone experiences and debates, and the poster sessions, all of which will widen the knowledge tree of IFIC and are an extremely useful resource for the integrated care community, policy makers, managers, researchers, patients and professionals.

Almost two decades ago, visionaries and pioneers such as Guss Schirvers and thorough and passionate researchers such as Nick Goodwin, laid the foundations of Integrated Care and the current 'Movement for Change'. Their achievement resulted in a network of more than 20,000 participants around the world, and at present the movement is heading towards a new phase. Behind the scenes of organising ICIC19



Bringing a conference to a region is no small undertaking, in particular when so many countries and disciplines are represented at one

conference. San Sebastian welcomed over 1,300 delegates representing 60 different countries, and multiple professions for the 19th International Conference on Integrated Care (ICIC19). They were received by our gracious hosts OSAKIDETZA – Basque Health Service, Bioef, the Ministry for Health of the Basque Government, the City Council of Donostia-San Sebastian and the Provincial Council of Gipuzkoa. Here in his post conference blog, Koldo Piñera Elorriaga, Senior Technician at BIOEF, talks about the experience of bringing the conference to the Basque region.

"Seeing the San Sebastián Kursaal Congress Centre brimming with over 1,300 colleagues interested in integrated care, a record to date at ICIC conferences, was a great pleasure for everyone who has been involved in organising ICIC19 to a greater or less extent, particularly after a year of intense work.

This all began in May 2016 when a team from IFIC accompanied a group from the United Kingdom and New Zealand on a study visit to the Basque Country. Three days of meetings, presentations and visits reflected the interest generated by progress in care integration in the Basque Health Service (Osakidetza). We saw the IFIC's work first-hand and, for the last few years, we had been attending a variety of conferences such as in Edinburgh and Mexico in 2015. In a joint reflection with the Ministry for Health of the Basque Government, we came up with the idea that there might be an excellent opportunity to host an edition of ICIC in the Basque Country and share the Basque integration experience with the rest of the world alongside the latest progress in the field. So we suggested it to Nick Goodwin and his team.

After acceptance from IFIC in Dublin 2017, we gradually got down to work. [Read more]"

Capacity building and technical support for implementing Integrated Care in Europe




The European Commission, Directorate-General Health and Food Safety, in collaboration with the International Foundation for Integrated Care (IFIC), organised a workshop and a marketplace on "capacity building and technical support for implementing integrated care".

The aim of these events was to bring together the "demand" and "supply" sides, i.e. respectively the authorities responsible for organisation of health care systems and organisations/experts capable to provide knowledge and expertise on how to implement integrated care. During the events, the two sides had the opportunity to talk to each other and consider potential co-operation on transforming health systems. The workshop took place on 1st April. It started with presentations on EU level actions and instruments to help build capacity and mobilise financing for the implementation of integrated care, including the type of technical assistance provided by the European Commission's Structural Reforms Support Service. There were also presentations of three EU projects: <u>SCIROCCO Exchange</u> and <u>VIGOUR</u> (funded by the EU Health Programme) and DigitalHealthEurope (funded by Horizon 2020). Twinning activities and knowledge exchanges between early adopters (authorities with greater experience in integration of care) and the next adopters (less experienced ones) are part of these projects. 'Movement for Change' enters new phase of expansion



"There is so much more to learn, to explore, to research, and to observe before we begin to fully understand 'what works' and how and whether integrated care can be implemented successfully" says outgoing IFIC CEO, Dr Nick Goodwin. Here Nick looks to the future expansion of the 'Movement for Change', as he takes on a new role as Professor and Director of the Central Coast Research Institute in Australia, while continuing to lead IFIC's expansion in the Asia-Pacific region.

"The 1300 persons present in San Sebastian are for the most part 'converts' to integrated care and, as innovators themselves, feel very much at home with like-minded colleagues seeking to find positive reinforcement of their interests. This is one reason why the 'feel' of ICIC conferences is often like no other – we are not alone, our conversations are mutually enhancing, our core ideas are shared. Yet, we are still at the beginning of the integrated care movement. There is so much more to learn, to explore, to research, and to observe before we begin to fully understand 'what works' and how and whether integrated care can be implemented successfully, to scale appropriately, and to have a lasting impact on improving the health and wellbeing of people – especially the most vulnerable in our societies who would benefit the most from better care coordination but today are the least likely to receive it.

This represents a new challenge for IFIC which is why it has changed its statutes to go beyond an organization that seeks to bring people together to advance the science, knowledge and adoption of integrated care in policy and practice. Today, IFIC stands as a movement for change with a vision in which all individuals, families and communities should be engaged and empowered to maximise their health and wellbeing through person-centred integrated care. Whilst maintaining a critical eye on whether integrated care is able to achieve its promise, IFIC in the future will seek to advocate and to influence the debate more directly than before – so building on its core strengths and academic credibility to speak to a future where integrated working should become the norm and not confined to special projects running on the sidelines.

IFIC's growing network, now nearly 20,000 individuals strong, will be supported in the future through the development of regional hubs and collaborative centres – such as those already running vibrantly in Australia, Canada, Scotland and Ireland. The 'hub' concept seeks to help grow awareness of IFIC's activities and to co-create work together with local partners that support and fund its work, build its network, grow capacity and capabilities, and to support knowledge sharing. Global cross-pollination of ideas to solve local problems



"Have you ever tried to cook something outside of the dish's country of origin? It tastes different. No matter how thoroughly you read and follow a recipe. It still tastes different. The soil, the air, the water, in essence, the elements that affect the ingredients are different. Therefore, the result is different too. Not better or worse, but not the same."

Dr Edelweiss Aldasoro joined IFIC in 2018 as a Senior Fellow and works on a range of education and communication projects including three European research projects; EURIPHI, VIGOUR and Digital Health Europe. She is a qualified medical doctor and prior to joining IFIC specialised in General Internal Medicine and Infectious Diseases in Osakidetza in the Basque region. It was therefore a special conference for Edelweiss as she returned as an international researcher to her home town. Here in her blog, Edelweiss reflects on the what bringing an international conference to a country means for the local context and talks about the post conference study tour visiting several health and social care sites in the region.

"...the journey started on Tuesday, the second day of the conference, with delegates from Wales sharing some of their experiences in a room full of people even though it was very early in the morning. We learned how the Bevan Commission supported innovative initiatives to adapt the traditional way of working in Wales. Some examples included the role adaptation of workers in a Primary Health Care centre to solve staff shortage, projects to identify workforce crisis and create support and coaching strategies to help local students, the transformation of midwifery services to adapt to rural context, app development to diagnose dementia or interventions for children at risk of early language and behaviour difficulties. The audience was challenged to think out of the box, rebalance power in the system, recognise shared responsibility of the society in the population well-being and think on the concept of prudent healthcare. To sum up, to think different. "We have to change the way we think to change practice" and "if we keep doing the same things, we will get the same results", we heard.

After the conference we visited the the Hospital of Mendaro, part of the Integrated Health Organisation of Debabarrena (Gipuzkoa) and the Primary Health Care Centre of Zabalgana in Vitoria-Gasteiz (Araba). They were two fascinating examples of adaptation to local population characteristics and demands, from rural to urban, older and younger populations, prevalence of chronic or acute diseases. Spotlight on Learning from International Experiences in Funding and Financing Workshop



This round-table brought together a panel of experts on the funding and financing of integrated care. The focus of the roundtable was to debate the issues in how best incentivise integrated service provision, specifically as it pertains to people with vulnerable needs. The round-table was supported by the European Commission Structural Reform Support Service.

This interactive and informative session was chaired by Andrew Terris, Senior Associate, IFIC and Hali Tarum, Head of Social Welfare Department, Ministry of Social Affairs, Estonia who asked three questions: How to find the right balance between flexibility / local empowerment, specifically when defining a care coordination model? How can financing and incentive models help use flexible models more effectively?;

What have been the international lessons learned from jointcommissioning solutions? What is the optimal number of stakeholders that should be included in the contract? and; How to best introduce performance elements in coordination model?

Compassionate Inverclyde has built community resilience through neighbourhood networks and relationships with people who care and can help, enabling and equipping compassionate citizens to offer support at times of crisis. People facing bereavement, loneliness, and survivorship access compassionate support that improves wellbeing, irrespective of age, condition or socio-economic background. The runner up prize for best paper went to Sarah Derrett from University of Otago in New Zealand for Paper 588 "Health systems and genuine engagement: experiences and outcomes of a New Zealand Community Health Council". The Community Health Council was established to enhance community, whānau (Māori word for family), and patient experiences; improve service integration; promote equity and; ensure services are organized, and provided, to better address people's needs. Spotlight on The OMIS Room: Experiences of End of Life Integrated Care



The OMIS Room at ICIC19 focused on innovations in integrated care particularly focusing on innovations from Spain and in the field of palliative and end of life care in association with IFIC Scotland and the Palliative and End of Life Care SIG.

"Christina Castillo-Rodriguez of the New Health Foundation chaired this fascinating session on approaches to care for people at the end of their lives in a more compassionate, integrated and person driven way.

The first presentation was from Dr Arturo Alvarez-Rosete, from the New Health Foundation who are the organisers of The OMIS Room. The New Health Foundation is a non-for-profit institution with the aim of addressing the quality of life of people with advanced diseases, high dependency and at the end-of-life. Dr Alvarez-Rosete described the NewPalex method, a systematic working approach for the development, management and leadership of Palliative Care programmes and resources. Organisations can obtain NewPalex certification through complying with a set of standards within the organization, compiled by a consensus of experts and based on internationally recognized standards. He described how this was implemented in Colombia – an article on this will be published in June in the Journal for Palliative Care. [Read more]"

Canada make a growing contribution to the global movement for change

Here Walter Wodchis from the University of Toronto reflects on Canadas contribution to the 'Movement for Change' and looks towards Toronto 2020 and the launch of IFIC Canada, the North American Centre for Integrated Care.

"The ICIC 2019 conference in Donostia-San Sebastian was a wonderful opportunity for Canadians to learn who in Canada is working to better understand, improve and advance integrated care. This year's conference was attended by the largest number of Canadian delegates to date with more than 40 participants, many of whom gathered for an early breakfast on the final day of the conference hosted by the Health Standards Organization. Everyone was highly engaged and involved throughout the conference: Canadian contributions included a keynote talk by <u>Dr. Henry Mintzberg</u>, 22 oral presentations, 12 poster presentations, 11 session chairs and 6 workshops involving 19 presenters (clearly some people had multiple contributions). Dr. Jacobi Elliott was awarded Best Poster of the Conference (having already won the Best Poster award in 2016 in Barcelona and Runner-Up Poster in 2014 in Sydney). More than that

though, the Early Researchers in Integrated Care is an international group led by Mudi Kadu, a PhD student at the University of Toronto, and three other Special Interest Groups are facilitated or co-facilitated by Canadians including Digital Health Enabling Integrated Care, Volunteers and Voluntary Sector, and Advanced Education in Integrated Care. Director of Research & Innovation Associate Professor of Surgery, Harvard Medical School

Dr. Yule is a leading academic psychologist with specific expertise and training in organizational psychology, human factors science and mixed methods. He is internationally recognized for his research on assessing nontechnical skills and patient safety in surgery. Prior to moving to Boston from Scotland, he developed considerable experience studying team performance and safety in industry sectors as diverse as energy, transportation, and healthcare. Most notably, he was one of the pioneers in developing the 'Non-Technical Skills for Surgeons' (NOTSS) behavior observation system, which is now being implemented for surgical education and research in North America, Europe, Australia, Africa and Asia. Dr. Yule is lead author on several seminal papers on the topic and co-founded the Harvard Non-Technical Skills Laboratory, which brings together a multidisciplinary group of scientists who are passionate about studying the impact of non-technical skills on process measures and patient outcomes, as well as implementing scalable interventions to enhance patient safety. Simulation is core to this mission and at STRATUS, Dr. Yule ensures that the curricula are rigorously developed and reviewed to provide the most immersive and beneficial

experience for learners. He represents STRATUS nationally in his roles as vice-chair of the American College of Surgeons (ACS) committee on non-technical skills and as Honorary Fellow of the Royal College of Surgeons of Edinburgh which was awarded in 2019 for his pioneering contribution to education and assessment of non-techncial skills globally. Locally, he is also an associate faculty member at the Center for Surgery & Public Health, and Ariadne Labs for Health System Innovation.


