### Establishing CAIPE as an independent and legally constituted organisation

- First CAIPE bulletin published 1990

## Increasing credibility of CAIPE in UK; gaining recognition of its unique contribution to IPE

- Mutual understanding between CAIPE and the Journal of Interprofessional Care to complement and support
- Name changed from 'National Centre' to 'Centre for the Advancement of IPE'

# Focus on UK pre-registration education and expansion of international development: a period of maximum activity for CAIPE

- Close involvement with, e.g. Learning for Partnership Network, Higher Education Academy subject centres, DH funded Common Learning Sites, Creating and Interprofessional Workforce and National Patient Safety Agency, the GMC and Inter-regulatory Group.
- Today, Yesterday and Tomorrow (Hugh Barr) published 2002 and the first of CAIPE Blackwell books
- Partnership in the European Interprofessional Education Network, and in All Together Better Health Conference London 2006 and increasing involvement in the development of IPE in Japan through exchange of visits
- Increasing number of CAIPE workshops, commissioned and independent

#### **Review and reorganisation**

- Rapid growth of work, but escalating costs and loss of expected income led to financial crisis; CAIPE became a 'virtual' organisation
- Student membership and board representation introduced, and biannual forums for corporate members and Chairs Event for individual members
- Fewer workshops in UK but more international including Australia, New Zealand, Japan and Europe
- Continuation of other international work including support for IPE networks in Australia, Canada, USA, Europe and Japan, WHO IPE Framework Group; continued arrangement of exchange visits from outside the UK
- Green Book for Regulators and Commissioners 2012
