The geography of the Covid-19 crisis in England

This report analyses how the health, economic and social impacts of Covid-19 vary around England. It explores which local authorities (LAs) have residents who are more vulnerable to severe Covid-19 symptoms because of their age or pre-existing conditions; which LAs have a greater share of workers in shut-down sectors such as retail or hospitality; and which LAs have a greater share of children either eligible for free school meals or receiving children's social services, who might be at particular educational or social risk from the crisis.

The mental health effects of the first two months of lockdown and social distancing during the Covid-19 pandemic in the UK

This report discusses the impact of Covid-19 on mental health. It finds that mental health in the UK has worsened substantially as a result of the Covid-19 pandemic, particularly for groups that already had lower levels of mental health before Covid-19, such as young adults and women.

BAME women and Covid-19: research evidence

This analysis from the Fawcett Society – together with the Women's Budget Group, Queen Mary University London and the London School of Economics – reveals the pressure on BAME women during the coronavirus lockdown. Forty-three per cent of disabled or retired BAME women and 48 per cent of BAME men say that they had lost government support, compared with 13 per cent of white women and 21 per cent of white men. More than half (51 per cent) of BAME women say they were not sure where to turn for help, compared with one in five (19 per cent) of white women. This is despite the fact that BAME people have been found to be more at risk during the pandemic.

Sexual and reproductive health return on investment tool

This tool quantifies the costs and benefits associated with a range of sexual and reproductive health interventions. It focuses on young people (aged 15 to 24). It allows users to estimate the impact commissioning different services would have on population health and cost savings for local authorities, the NHS and wider government. The tool can be set to focus on the national level or in users' local area (region, local authority or CCG).

Spotlight on adolescent health and well-being: findings from the 2017/2018 Health Behaviour in School-aged Children (HBSC) survey in Europe and Canada.

Health Behaviour in School-aged Children (HBSC), a WHO collaborative cross-national study, has provided information about the health, wellbeing, social environment and health behaviour of 11-, 13- and 15-year-old boys and girls for more than 30 years. The 2017/2018 survey report presents data from more than 220,000 young people in 45 countries and regions in Europe and Canada. The data focuses on social context, health outcomes, and health and risk behaviours relevant to young people's health and wellbeing. This report includes new items on electronic media communication and cyberbullying, and a revised measure on family meals. Additionally, measures of individual health complaints and underweight are also included for the first time in this international report.

What is the current alcohol labelling practice in the WHO European Region and what are barriers and facilitators to development and implementation of alcohol labelling policy?

This report synthesizes evidence on alcohol labelling practices in the Region and aims to describe factors affecting implementation. It argues that policy considerations for the development of successful labelling legislation should ideally address both health information and nutritional information, ensure regulated message presentation, and implement the independent monitoring and evaluation of these measures.

Local delivery: protecting social infrastructure

This report recommends that ministers must fund and empower local people to run vital community businesses and service hubs that can help neighbourhoods thrive beyond

the immediate Covid-19 pandemic. It calls on central government to show consistency and political will in supporting grass roots community ventures – or risk hampering recovery by sapping the energy and enthusiasm of capable volunteers.

Carers Week 2020 research report: the rise in the number of unpaid carers during the coronavirus (Covid-19) outbreak

The six Carers Week charities – Carers UK, Age UK, Carers Trust, Motor Neurone Disease Association, Oxfam GB and Rethink Mental Illness – have published research based on polling carried out by YouGov in May 2020 of 4,557 people over the age of 18 living in the UK. The figures show an estimated 4.5 million people in the UK have become unpaid carers as a result of the Covid-19 pandemic. This is on top of the 9.1 million unpaid carers who were already caring before the outbreak, bringing the total to 13.6 million. 2.7 million women (59 per cent) and 1.8 million men (41 per cent) have started caring for relatives who are older, disabled or living with a physical or mental illness.

Covid-19: review of disparities in risks and outcomes

This is a descriptive review of data on disparities in the risk and outcomes from Covid-19. This review presents findings based on surveillance data available to Public Health England at the time of its publication, including through linkage to broader health datasets. It confirms that the impact of Covid-19 has replicated existing health inequalities and, in some cases, has increased them. These results improve our understanding of the pandemic and will help in formulating the future public health response to it.

This report highlights that tackling preventable illness must remain a top priority for the government in the 2020s. More than half of the disease burden in England is deemed preventable, with one in five deaths attributed to causes that could have been avoided. NLGN Leadership Index - edition #9: Covid-19

NLGN's Leadership Index is a quarterly survey sent to all chief executives and council leaders/mayors in the UK. It asks council chiefs about their level of confidence in key service areas as well as wider indicators of community wellbeing. The May 2020 survey also asked local government leaders how they are responding to the Covid-19 outbreak. Key findings include council chiefs calling for more support from government, and a significant drop in confidence in the economy, but with levels of community cohesion and trust reaching a new high.

Six-country survey on Covid-19

This paper presents a new dataset collected on representative samples across six countries: China, South Korea, Japan, Italy, the UK and the four largest states in the US. The information collected relates to work and living situations, income, behaviour (such as social distancing, hand washing and wearing a face mask), beliefs about the Covid-19 pandemic and exposure to the virus, socio-demographic characteristics and pre-pandemic health characteristics.

Age, death risk, and the design of an exit strategy: a guide for policymakers and for citizens who want to stay alive

This discussion paper provides information on the strong age pattern in the risk of death from three countries (China, Italy, the UK). Its authors believe that if politicians want an imminent removal of the lockdown, the safest approach would be a rolling age-release strategy combined with the current principle of social distancing. But even if that is not the policy adopted, citizens need to be shown graphs of the kind in this paper. Honest guidance ought to be given to those in midlife and beyond. Governments have to allow people to understand their personal risk after any release from lockdown.
